#### **Treasurer's Report**

Pat Sutton went through the Financial Accounts and confirmed a bank current account balance of €105. PayPal account balance of €104. The Lotto Account had a balance of €19,925. The Loan account had an outstanding balance of €28,959.41

Chairman commented on the report and noted that the club's finances were in a very vulnerable place and that it's always a constant area of concern. Des highlighted the effort that is required when it comes to fundraising. He called for everyone to help and noted special thanks must go to the lotto. He said a special word for thanks to everyone who pays their membership (Membership and lotto is key to success especially when it comes applying for grants. He notes that costs were kept to a minimum. The Chairman finally thanked Pat Sutton for his excellent report and the work that both himself and Paddy did during the year.

Des thanked everyone for their attendance today. He thanked the executive committee and he noted that some members participation was not a good as it could be. He said anyone who takes a role they have to give full commitment. He wished Eamon all the best in his new adventure and thanked the ladies for the commitment involved during the year. He thanked the teams the players and noted that lack of commitment with certain players on the Flagship team. He noted no junior team this year and he said that has to be addressed. The underage and ladies are thriving. He thanked the underage under the stewardship of Mark Prendergast and noted how well the underage teams have done. The Chairman said the ladies also had a brilliant year and congratulated them on winning club of the year he also noted the success of the senior, minor and underage ladies and wished them well for 2017.

Chairman spoke about the finances and noted the lack of interest he said Many will give out but don't seem to get involved.


